The admission process will be conducted strictly according to the merits of the applicants and strictly in compliance with the guidelines/government orders/circulars/memos/directives etc. issued by the Department of Higher Education, Science and Technology and Biotechnology, the University of Calcutta and the University Grants Commission.

All concerned are further advised to note the following important points:

- 3. Publication of Merit List ON-LINE MODE ONLY
- 4. The Merit-Listed applicant must UPLOAD the Documents (as per his/her declaration in the forms submitted on-line).
- 5. Admission through ON-LINE MODE ONLY
- 6. Payment for Admission Fee ON-LINE MODE ONLY
- 7. All admissions should be PROVISIONAL subject to document verification after the commencement of classes.
- 8. Applicant must NOT visit the college before the commencement of classes.
- Provisionally Admitted Student must report for documents verification on scheduled Date & Time after the commencement of classes (to be notified later)
- 10. Admission will be CANCELLED if during verification, the original documents are found NOT in conformity with the information submitted on-
- 11. If the Provisionally Admitted Student fails to report for documents verification on scheduled date & Time then his/her admission will be CANCELLED.
- 12. BOYS are NOT allowed for MORNING Section Admission. On-line Application will be CANCELLED.
  - GIRLS are NOT allowed for EVENING Section Admission. On-line Application will be CANCELLED.
  - SEPARATE applications are to be made for each Section.
  - SEPARATE applications are to be made for each Course.
- 13. Once admitted, TRANSFER from one section to another (e.g. from morning to day, day to morning etc.) will NOT be allowed.
- 14. FAILED subject at the previous qualifying examination will NOT be allowed to take up as a subject in the Honours/General Courses. Students must have Pass marks in the PRACTICAL & THEORY Papers separately.
- For Honours Course: In each set of three subjects, First subject denotes Honours (Core) Course and rest Two subjects denote General(elective)
  Courses.
  - <u>For General Course</u>: In each set of three subjects, Any Two subjects to be chosen as Core Course (CC) and the Third subject will be Generic Elective (GE).
  - Students must select all the subjects for all the six semesters at the time of filling up the on-line admission form.
- 16. <u>Choice of Subject Combination is subject to availability of seats</u>. The applicants may choose General Subject(s) as per their choice. However, if the subject combination chosen by the student is not available due to limitation of intake capacity, then the concerned student will be bound to accept the available subject combination offered by the college authority.

# B.A./B.Sc (Honours/General)Course of Studies

(Excerpts) vide CSR/3/18 dated 07/05/2018

4(a) A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.A./B.Sc. (Honours/General)Course of Studies provided he/she has also passed in English having full marks not being less than 100 and fulfills the conditions as laid down in Clauses 5,11, 12 and 13.

Candidates who have passed the Higher Secondary (10+2) Vocational examination conducted by the West Bengal State Council of Vocational Education and Training shall be eligible to seek admission to the B.A. (General) 1st year Course of Studies taking the subjects under Humanities Division only.

However, no candidate shall be allowed admission after a lapse of more than 5 years from the year of passing the previous qualifying examination. Explanation: The year of admission shall not be taken into account while calculating five years from the year of passing the previous qualifying Examination.

(b) Students who have passed the Higher Secondary (10+2) Examination or its equivalent from the All India Boards/Councils (i.e. CBSE, ISC and National Institute of Open Schooling) need not require to submit Migration Certificate for getting Registration under this University.

**5.For the purpose of determining eligibility for admission** to the B.A./B.Sc./B.Mus. (Honours/General)Courses, aggregate marks shall be calculated by adding the marks in top-four subjects in order of marks secured by a candidate. Marks in compulsory Environmental Education/Studies shall not be taken into account for calculation of aggregate marks. However, if the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks.

### (a) A candidate taking up Honours Course in a subject must have obtained:

- i. A minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination
  - Or
- ii. 55% marks in the subject or related subject at the previous qualifying examination

Or

iii. 50% marks in the aggregate when the candidate has not studied the subject in his/her previous qualifying examination provided all other clauses are satisfied

(b) Candidates belonging to Reserved Categories taking up Honours Course of Study must have obtained a minimum of 40% marks in the aggregate or 40% marks in the subject or related subjects at the previous qualifying examination, as the case may be.

(c)Reservation Policy for admission in three year (six semesters) degree courses of studies shall be guided by the West Bengal State Higher Educational Institutions (Reservation in Admission), Act, 2013 and the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2014.

## 13. Special conditions for admission to the following Honours Courses

- (i) Economics: A Candidate shall be allowed to take up Honours in Economics if he/she has passed in Mathematics at the H.S. Examination (10+2) conducted by the West Bengal Council of H.S. Education or its equivalent examination in Mathematics/ Business Mathematics. Students who have passed Business Economics including Business Mathematics in H.S. (10+2) level from West Bengal Council of H.S. Education are also eligible for admission in the Honours Course in Economics. Candidates of Economics Honours have to take up Mathematics as one of the elective subjects.
- (ii) Mathematics: A candidate shall be allowed to take up Honours in Mathematics if he/she has passed in Mathematics at the previous qualifying examination. A candidate who has passed in Business Mathematics is not eligible for admission to the Mathematics Honours Course.
- (iii) Chemistry: A candidate shall be allowed to take up Honours in Chemistry if he/she has passed in Physics, Chemistry and Mathematics at the previous qualifying examination.
- (x) Computer Science: The combination of subjects for Computer Science Hons. Course shall be Mathematics as one of the General subjects and any one of the following subjects: either Physics or Statistics or Electronics.
- (xi) Education: If the candidate has not studied Education as a subject in the previous qualifying examination then Psychology/ Philosophy/ Mathematics/ Sociology/ Economics/ Political Science / History/ Statistics/ Physics/ Chemistry/ Biology are treated as related subjects.
- (xii) Philosophy: If the candidate has not studied Philosophy as a subject in the previous qualifying examination then Psychology/ Math/ Education/ Sociology/ Political Science be treated as related subjects.

# B.Com. (Honours/General)Course of Studies

(Excerpts) vide CSR/26/17 dated 26/05/2017

1. A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year B.Com. (Honours/General)Course of Studies provided he/she has also passed in English having full marks not being less than 100 and fulfills the conditions as laid down in Clauses 2.

Candidates who have passed the Higher Secondary (10+2) Vocational examination in Business & Commerce conducted by the West Bengal State Council of Vocational Education and Training shall be eligible to seek admission to the B.Com. (General) 1st year Course of Studies under this University.

However, no candidate shall be allowed admission after a lapse of more than 5 years from the year of passing the previous qualifying examination. Explanation: The year of admission shall not be taken into account while calculating five years from the year of passing the previous qualifying Examination.

For the purpose of determining eligibility for admission to the B.Com. (Honours)Courses, aggregate marks shall be calculated by adding the marks in top-four subjects in order of marks secured by a candidate. Marks in compulsory Environmental Education/Studies shall not be taken into account for calculation of aggregate marks. However, if the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks.

- 2. (a) A candidate taking up B.Com. Honours Course in a subject must have obtained:
- i. A minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination.

Or

- ii. 55% marks in the subject or related subject at the previous qualifying examination
- (b) However, candidates belonging to Reserved Categories taking up Honours Course of Study must have obtained a minimum of 40% marks in the aggregate or 40% marks in the subject or related subjects at the previous qualifying examination, as the case may be.
- (c)Reservation Policy for admission in three year degree courses of studies shall be guided by the West Bengal State Higher Educational Institutions (Reservation in Admission), Act, 2013 and the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2014.
- (d)Following subjects be treated as related subjects for admission to B.Com. (Honours) Courses:

Accountancy/ Business Economics including Business Mathematics/ Business Organization/ Mathematics/ Economics/ Statistics/ Commerce/ Accounts/ Business Studies/ Financial Accounting/Office and Secretarial Practice/ Elements of Cost Accountancy and Auditing/ Book Keeping/ Business Mathematics/ Cost Accountancy & Principle of Management, Commercial Law and preliminaries of Auditing, Costing and Taxation.

(e) A candidate shall be allowed to take up B.Com. (General) Course if he/she had passed the subject(s) at the previous qualifying examination as mentioned below:

Accountancy/ Business Economics including Business Mathematics/ Business Organization/ Mathematics/ Economics/ Statistics/ Commerce/ Accounts/ Business Studies/ Financial Accounting/Office and Secretarial Practice/ Elements of Cost Accountancy and Auditing/ Book Keeping/ Business Mathematics/ Cost Accountancy & Principle of Management, Commercial Law and preliminaries of Auditing, Costing and Taxation.

**3.** Students who have passed the Higher Secondary (10+2) Examination or its equivalent from the All India Boards/Councils (i.e. CBSE, ISC and National Institute of Open Schooling) need not require to submit Migration Certificate for getting Registration under this University.
