NOTICE

Online submission of Assignment for Post Graduate Term-End Examination, June 2022 / December 2022 and Online submission of Assignment for Bachelor of Library & Information Science (BLIS) Term-End Examination, December 2022 have been completed on 04/01/2023 (2:00 p.m.). In our earlier Notice (Memo No.: COE/429/2022, Dated: 20/09/2022 and Memo No.: COE/309/2022 Dated: 12/10/2022, in page no. 3, point no. 1) it has been clearly mentioned that at the time of Examination “**OTP will be delivered to either Registered or Alternative Mobile Number**”. So, the learner has been asked to put his/her own Mobile Number at the time of submission of Online Examination form. But it is observed that inspite of several instructions during submission of filled in form for examinations, some learners put the phone numbers of some other persons instead of their own Aadhar linked and/or the phone numbers which can be proved as their own phone numbers.

Therefore, the following situations have been occurred:

- 1) Registered mobile number of some learners are also the alternative mobile number of one or more than one learners.
- 2) Alternative mobile number of some learners are also the Registered mobile number of one or more than one learners.

So those Registered mobile number and Alternative mobile number have been blocked. Consequently, it has not been possible to send the **confidential OTP** to any of these Mobile Numbers. As a result, the learners not allowed to submit their Online Assignment. For such cases, to submit the Online Assignment learners the candidates concerned will get another chance to put their another unique alternative mobile number to the dedicated portal for this particular purpose. So they are requested to follow the undermentioned procedure:

- 1) Only such learners who are having the above issues may click on the following link on the login page of online Assignment Submission Portal - “**My Registered Mobile Number and Alternative Mobile Number both have been Blocked.**”

- 2) To click the above link, the learner will be allowed to submit a form where :
 - a) A learner can put a their another unique alternative mobile number which must be unique in the sense that it has not been tagged to any other Enrolment Number/s. This **New Mobile Number should have an evidence /proof that is owned by the concerned learner.**
 - b) The learner has to upload a scanned image of one authentic document viz. his/her **Aadhaar Card / Bank Pass book etc. where the said New Alternative Mobile Number is printed and clearly visible.**
- 3) While submitting the form, that Mobile Number will be verified with an OTP. If this Mobile Number is **UNIQUE**, then validation will be **PASSED**.
- 4) If this Number is found to be already tagged with any other Enrolment Number/s in the database of, then an error message **“Sorry! That Mobile Number has been already tagged to another Enrolment Number. Please provide a Unique Mobile Number of your own”** will be displayed. Accordingly, validation will be **FAILED** and learner cannot proceed further. Then learner can click **‘CANCEL’** Button to return to login page.
- 5) After successful submission of the above-mentioned form, the learner may come back after 3 hours to visit the respective Online submission of Assignment portal login page to login his/her Assignment Submission Dashboard using the New Alternative Mobile Number supplied by him/her in the above-mentioned process.

It may please be noted that the learner concerned may avail the scope of correction of Alternative Mobile Number **from 12/01/2023 at 2:00 p.m. to 16/01/2023 at 2:00 p.m.** Considering the whole situation, it has been decided that the submission of Online Assignment will be **reopened for all learners for 4 days (4×24 hours) from 12/01/2023 at 2:00 p.m. to 16/01/2023 at 2:00 p.m.**
